

TRANSIT ADVISORY COMMITTEE

June 24, 2019

Assistant City Manager Mark Morgan opened the meeting at 5:05pm. Transit Advisory Committee members in attendance were Dean Fialka and Kristi Avery. Jennifer Roberts, Barb Martin, Juli Gregory, Kristi Avery, Cindy Schann and Councilor Doug Primmer were not present. Also present were Council Representatives Rod Hardin, Chief Edmiston, CTUIR Scheduling Coordinator Susan Johnson, CTUIR Fleet and Safety Director Rob Johnson, Kayak Planning Director JD Tovey (via/phone at 5:10pm), and City Recorder Lilly Alarcon-Strong.

11th & Ridgeway and 11th & Hartley

Mark and Susan presented information regarding moving 11th & Ridgeway to 7th & Ridgeway in order to accommodate a larger pool of residents near low-income housing, Ridgeway Apartments.

The Committee asked to postpone this action until further data is available.

Fiesta Food/Grocery Outlet

Mark and Susan recommended the Committee leave the stop as is, as although Fiesta Foods has moved out of this building, Grocery Outlet will be opening in the same building by the end of the year.

The Committee agreed.

13th & Madrona Drive- Highland Park

Mark and Susan gave information regarding the lack of ridership on 13th & Madrona (1 ride in 5 months), and recommended that the Committee move this stop to 9th & Main or by the Skating Rink. Susan stated CTUIR relies on their drivers to let them know what ridership is and give suggestions as well.

The Committee asked that the stop be kept as is, but add a stop by the Skating Rink to test the area and see how much ridership that stop would get. The use of temporary signs would be placed in the Skating Rink area.

7th & Main Street

Mark and Susan suggested that this stop be moved to 5th and Main with the belief more people would use this stop as it is closer to the city center. Members of the public have also suggested this change.

The Committee asked that this stop be left as is at the moment.

Columbia Drive Bus Shelter & Possible New Stop at SE 9th

Mark, Susan and Rob suggested placing an additional near all three areas: Stafford Hansell Government Center (Circuit Court), BMCC, and DHS buildings. This could be accomplished by moving one in-front of BMCC Higher Ed Center and adding the other west of the Circuit Court as there is a lot of ridership at the Court.

The Committee suggested working with Stafford Hansell Government Center and BMCC to possibly place bus shelters at both areas.

The Committee reviewed the April 1st – June 30th HART Map and Ridership information attached).

June 24, 2019

Susan stated dispatch gets more calls about HART than another bus service they provide. Ridership continues to grow and the Committee can expect to see an increase of ridership when the bigger bus comes online, as it is more visible, bigger, easier to get in and out of, and more comfortable. CTUIR is in search of a CDL driver to get this bus online. Unfortunately, there is a lack of CDL drivers in the area.

Adjournment

There was no other business and the meeting was adjourned at 5:42pm.

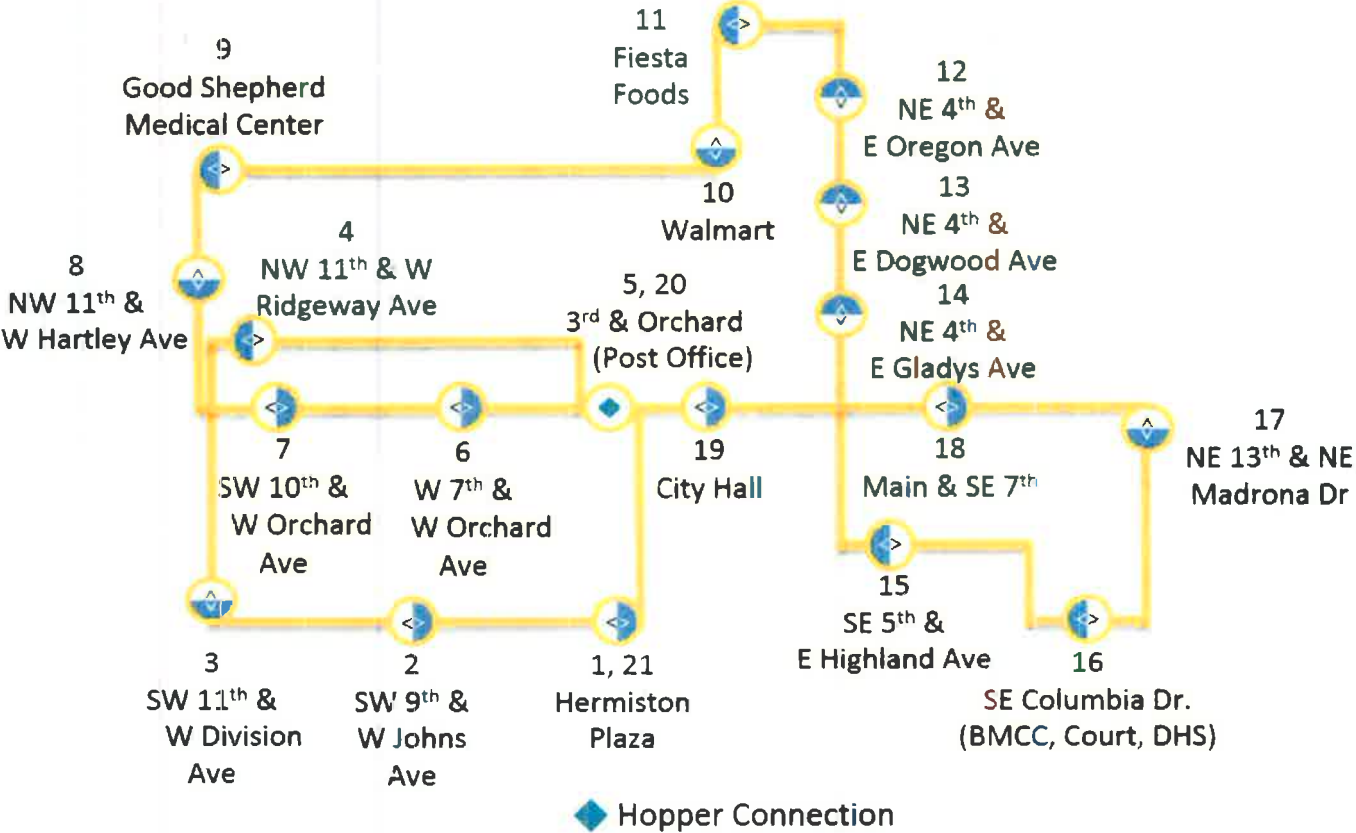
