

RESOLUTION NO. 2147

WHEREAS ORS 271.130 establishes that a city may undertake vacation proceedings by its own motion; and

WHEREAS the city council moved on April 27, 2020 to initiate vacation proceedings for a portion of E Ridgeway Ave beginning at the south right of way of NE 8th Place and ending at the north right of way of E Diagonal Blvd as shown on Exhibit A to this resolution; and


WHEREAS ORS 271.130 establishes that a vacation proposed by the city's own motion shall not be undertaken without a public hearing in accordance with the requirements of ORS 271.080 through 271.110; now therefore

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF HERMISTON, OREGON, a public hearing on the question of vacation of the above described portion of E Ridgeway Ave is scheduled for May 26, 2020 at or after 7:00 pm Eastern Oregon Trade and Event Center (EOTEC), 1705 E Airport Road. Notice of said hearing will be published in the Hermiston Herald on May 6 and 13, 2020 and posted at each end of the affected right-of-way on May 6, 2020 in accordance with ORS 271.110.

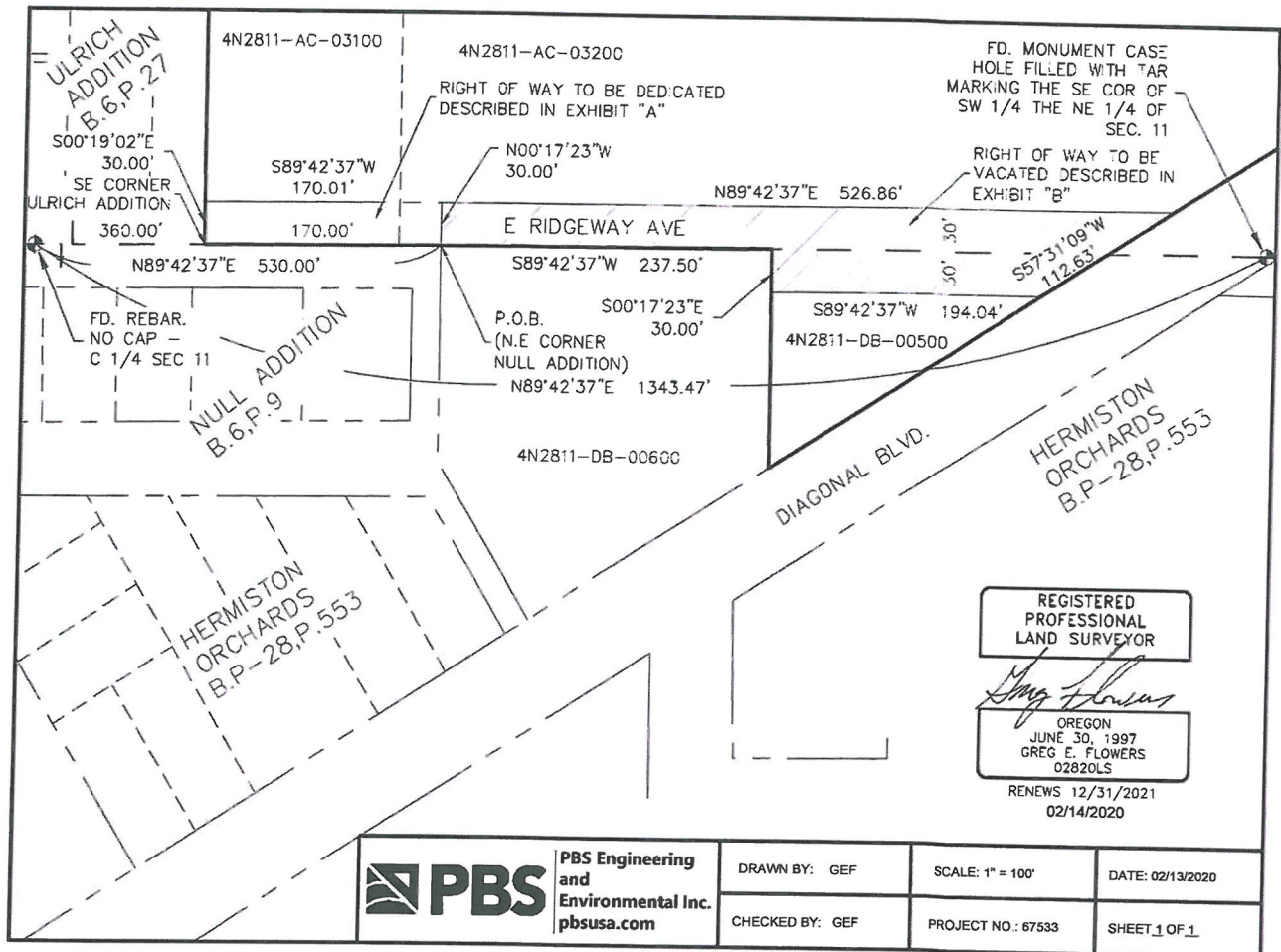

Exhibit A to Resolution No. 2147

EAST RIDGWAY VACATION DESCRIPTION

Commencing at the Center ¼ corner of Section 11, Township 4 North, Range 28 East of the Willamette Meridian, Umatilla County, Oregon which marks the centerline intersection of Northeast 7th Street with East Ridgway Avenue and running thence N89°42'37"E, along the centerline of East Ridgway Avenue and the South line of the Northeast 1/4 of said Section 11, a distance of 530.00 feet to the Northeast corner of Null Addition according to the official plat thereof recorded in Book 6 , Page 9 of Town Plats of Umatilla County, Oregon and the True Point of Beginning for the description; thence, at right angles to the South line of the Northeast 1/4 of said Section 11, N00°17'23"W a distance of 30.00 feet; thence N89°42'37"E, parallel with the South line of the Northeast 1/4 of said Section 11, a distance of 526.86 feet to the West line of Diagonal Boulevard; thence S57°31'09"W, along the West line of said Diagonal Boulevard, a distance of 112.63 feet to a point on a line 30 feet South measured perpendicular from the South line of the Northeast 1/4 of said Section 11; thence S89°42'37"W, parallel with and 30 feet distant South of the South line of the Northeast Quarter of said Section 11, a distance of 194.04 feet; thence N00°17'23"W a distance of 30.00 feet to a point that is 767.50 feet East, when measured along the South line of the Northeast 1/4 of said Section 11, from the center of said Section 11; thence S89°42'37"W a distance of 237.50 feet to the Point Of Beginning having an area of 21,627 square feet, 0.50 acres, more or less.

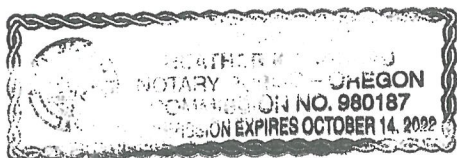


